In order for Carrera UK Limited to provide our products and services effectively, we may collect personal data from our customers. We may collect the following types of personal data:

How we collect or obtain your personal data

- From your use of our website or by using cookies and similar technologies

How we use your personal data

We use your personal information for administrative and business purposes (particularly to contact you regarding our services and products) and in connection with our legal rights and obligations.

Where appropriate, and with your permission, we may share your data with our trusted partners to utilise their products and/or services.

How we secure your personal data

We secure your personal data by using appropriate technical and organisational measures such as; storing your personal on secure servers and computers, encrypting transfers of data

to or from our servers, encrypting email messages via Secure Sockets Layer (SSL) and Transport Layer Security (TLS) and protecting any sensitive documents with secure passwords and encryption where possible. We also limit the access of your personal data to employees of Carrera UK Limited who have a legitimate need to access this information.

How long we retain your personal data

We will retain your personal data for no longer than necessary, taking into account any legal obligations we may have (e.g. to maintain records for tax purposes) and any other legal basis we have for using your personal information e.g. your consent, performance of a contract with you or our legitimate interests as a business. Where we no longer need your personal data we will dispose/destroy of it in a secure manner.

Disclosure of your personal data to third parties

Where appropriate, and with your permission, we may share your data with our trusted partners to utilise their products and/or services.

We will never sell any personal data to third parties or disclose your data to third parties without your permission.

Your rights regarding your personal data

You have right to request a copy of the information comprised in your personal data held by us. This is also known as a Subject Access Request. This enables you to confirm whether we hold and process your Personal Data and receive a copy of the Personal Data we are processing and certain information about how we use your Personal Data. It is important that the Personal Data that we hold about you is accurate and current.

Please keep us informed of your Personal Data changes. In certain circumstances you have the right to have inaccurate personal data rectified, blocked, erased or destroyed.
